### **CUSTOMS INFORMATION**

- Firearms, ammunition and explosives (unless licensed in advance)
- Obscene literature, photographs or films and politically "undesirable" literature
- · Prohibited drugs, misbranded and adulterated drugs and foodstuffs

#### 1. GENERAL PROCEDURE

Household and personal effects are dutiable. However, there is a provision for conditional exemption from duty which is accorded to certain categories of shippers: working foreigners, Diplomatic and USAID, UN and similar staff. Returning Filipino residents also receive limited exemption.

- Please note that clients are entitled to one tax & duty free shipment per visa so if they have an air and sea shipment, they will need to choose which one is to be exempted.
- If the client has shipped goods to The Philippines in the past (e.g. for previous assignments) please contact us for clarification as it may still be possible to import one shipment free of tax & duty.
- The following foreign visa categories are exempted from taxes/duties provided the visa is ready prior to shipments arrival: 9F, 9D, 47(a)2, 13A, 13E, 13G, EO226, DUAL Citizenship (i.e. Philippine passport holder at the same time Foreign passport holder), PD1034, and Special Work Permit for foreign press, foreign Embassy Diplomats, and Filipino Diplomats recalled for a new assignment.

#### 2. SHIPPING DOCUMENTS NEEDED (FOR ALL SHIPPERS)

- a) Ocean Bill of Lading or Airway Bill– (Seaway Bill or Express B/L)
- b) Inventory List (in English)

- c) Passport copy with signature page
- d) Certificate of Employment copy (for both air and sea)
- e) Signed and completed of affidavit of explaination (sea only)

#### 3. DOCUMENTS NEEDED FOR COMMERCIAL/NON-GOVERMENTAL ENTRIES

- a) Original Passport of working foreigner (needed for a few workdays)/ Phil Passport under dual citizenship.
- b) Visa (obtained after shipper's arrival and needed for sea shipment and affidavit of Legal Ownership) OR Visa application letter copy from employer to Bureau of Immigration and Deportation (BID) and the Re-export Bond Affidavit
- c) A Certification of Employment on Company letterhead
- d) Authorization to Lane Moving
- e) Employment Contract
- f) Marriage and Birth Certificates for dual citizenship/permanent residence visas
- g) ACR Card (Alien Certificate of Registration)
- h) Tax Account Number

### 4. DOCUMENTS NEEDED FOR DIPLOMATIC, GOVERNMENTAL AND UNITED NATIONS PERSONNEL

Copy of passport and Authorization to Asian Tigers are needed.

Shippers are exempt from duty and, in the case of Diplomats, from physical inspection of the goods as well. The Embassy needs the shipping documents in order to apply for "free-entry" to the Department of Foreign Affairs (DFA). The processing times can vary and it is the Embassy's responsibility to follow-up with DFA. Once completed with DOF, Asian Tigers receives a copy of the "free-entry" and can proceed with the release of cargo, which usually takes 2-3 workdays.

5. Imported goods should have been owned and in use at least 6 months before entry. The shipment should also arrive in the Philippines within 90 days period upon visa approval and 60 days of owner's arrival. Brand new appliances or what might be construed as "commercial quantities" in a shipment are discouraged. Customs clearance usually takes 1–3 workdays for airfreight and 7–10 workdays for surface freight once all personal and shipping documents are available. Foreign visa holders (except "Diplomatic" and Filipino returning residents), with a shipment which arrives before Visa approval, must post a Re-Export Bond for the conditional release of the shipment.

#### 6. VEHICLES

Prior to shipping, Authority/Clearance to import from Fair Trade Enforcement Bureau: Import Regulation Division must be acquired to avoid seizure / penalty. Currently, only returning residents and Diplomats are allowed this permission. An import permit is being obtained from Bureau of Import Services, Department of Trade, Manila. Personal documents are required plus Import Authority, stencils of chassis / engine numbers, Commercial Invoice or Deed of Sale, Car Registration certificate, and separate OBL (if vehicle is shipped in the container with the household goods).

#### 7. **PETS**

Pets are dutiable. Prior to importation shipper must secure Import Permit from Bureau of Animal Industry (Manila). To get this, the client must provide the following information: Kind of pet; Breed; Name of pet; Name of owner; Gender; Color; Tentative flight details / arrival information; Copies of health and vaccination certificates; Contact fax of agent or person handling the export formalities overseas.
