LIST OF PROHIBITED ARTICLES

- Pornographic materials
- Firearms (includes of model and toys gun)
- Swords and long knives (if the blade excluding the handle is longer than 15 cm, import is prohibited)
- Ammunition
- Narcotics and non-branded drugs
- Any item which is considered to be detrimental to public interest or national security

USEFUL INFORMATION / CUSTOMS REGULATIONS

1. The shipper's physical arrival in Korea should be documented or logged before the shipment arrives, but there is no requirement for the shipper to be physically present during Customs clearance. The shipment must be imported within six months from the date of the shipper's re-entry into Korea. All shipments are subject to inspection, except for diplomatic shipments. Only used household goods are eligible for Duty Free classification. Duties apply to new items (less than 3 months old), alcohol and tobacco products, used and new automobiles, boats, aircraft, motorcycles, and jewelry.

2. RECOMMENDED PORTS OF ENTRY

Surface Shipments : Incheon or Busan

Please note shipments coming to Busan port, below additional charges may occurred.

- Empty cntr returning charge (if any / only for POE: Busan): at cost billing (US\$250 – 350 / 20', US\$350 – 450 / 40')
- Cntr drop off charge (if any / only for POE: Busan): at cost billing (US\$80 – 120 / 20', US\$90 – 150 / 40')

Air Shipments

- a) Incheon Airport (Seoul) - airport of entry for any shipment
- b) Gimhae Airport (Busan) - for Busan and surrounding area

3. LOOSE LOADED CONTAINER SHIPMENTS

Korean customs regulations prohibit the port-to-door delivery of containerized goods, with the exception of diplomatic FCL shipments that do not include automobiles. All goods must be unloaded from the container at the customs bonded warehouse for inspection. Following customs clearance, shipments will be transported to the final destination residence via truck or van.

4. AUTOMOBILES

OBD (ON BOARD DIAGNOSTIC) is required.

All automobiles imported into the Republic of Korea are subject to significant duties and taxes unless they fall under specific exemptions for diplomatic or military personnel, as well as U.S. Governmental Contractors under the Status Of Forces Agreement (SOFA). To qualify for import, an automobile must be registered under the shipper's name for more than three months before being shipped to Korea. Providing proof of ownership and age, such as registration, title, insurance policy, and purchasing receipt, is essential.

Korean-made cars that have been in use for more than three months are exempt from import duties and taxes. However, it's important to note that a Korean vehicle assembled in a foreign country is not eligible for duty-free import; payment of duties and taxes is required in such cases. 5. DIPLOMATIC SHIPMENTS

Household goods and personal effects owned by foreign diplomats are not subject to inspection. Returning Korean diplomats are required to adhere to the same regulations as any other returning Korean resident. It is important to explicitly indicate "diplomatic shipment" on the ocean or air bill of lading.



6. DOCUMENTS REQUIRED FOR IMPORT INTO KOREA

For Returning Korean (Passport type : PM)

1. Passport copy
 2. Certificate of entry and exit (proving that shipper lives abroad at least 1 year)
 3. Completion of Customs form - To be provided
 4. Completion of Privacy Consent - To be provided
- * If client has accompanying family members, he/she must submit the family's documents as well.

For Non-residence

1. Passport copy
 2. Copy of the most recent entry confirmation (After shipper arrival into Korea)
 3. Copy of Korean visa with a minimum one year validity
 4. Completion of Customs form - To be provided
 5. Completion of Privacy Consent - To be provided
- If client has accompanying family members, he/she must submit the family's documents as well.

7. PETS

Dogs and Cats will be released through customs only after passing through a medical inspection at the National Quarantine Office at the Airport of Entry. A Microchip, Certificate of Health and a Rabies Vaccination Certificate from the country of origin are also required. No Quarantine period is required if the necessary customs documents are prepared properly.
