<p>Bolivian and Foreign Citizens Removal Goods – HHG/PE</p>	<ul style="list-style-type: none"> ▪ Copy of passport (where the complete data of each client is specified, it must include the photo and his/her personal signature). ▪ Copy of Bolivian or Foreign ID (Carnet de Identidad). ▪ In case of private clients, a letter from the company for which customer has been working in Bolivia indicating the cease of contract or new position at the destination country. ▪ Sworn statement “Declaración Jurada” indicating that customer is moving abroad with complete export details (quantity and/or pieces, weight, origin, destination, value for customs purposes, export frontier departure and that complies with the current regulations: <ul style="list-style-type: none"> ▪ declaring that among the used personal effects there are no objects such as Historical, Archaeological Cultural Heritage, and/or substances prohibited by the National Directorate of Narcotics Control and under the Law 1008. ▪ Fumigation certificate for packaging in wood, wicker, totora or rustic wood. ▪ Detailed Inventory 	<ul style="list-style-type: none"> ▪ Export documents are only valid within 3 months of being issued. ▪ All shipments are subject to physical inspection except the diplomats which can only be inspected as per a special Customs requirement. ▪ All export documents need to be written in Spanish (for Customs purposes). ▪ Passport must be within his validity period. ▪ Client must have more than 18 years old. ▪ The Sworn Statement must be in original and will be provided by your local agent ▪ Original and detailed Inventory. 	<ul style="list-style-type: none"> ▪ Shipments must be declared as HHGDS or Used Personal Effects. ▪ All Vehicles and/or Motorcycles are not considered as Personal Effects. ▪ Due to the high drug trafficking, customs require a more intensive control for all the export moves. Consequently, inspections with anti-narcotics (FELCN), guide dog anti-narcotics (K-9). ▪ It is always necessary to contact your local agent for any update on the required list of documents.
