| Used household Goods & Personal Effects (status non-Diplomatic) foreigner and /or Georgian citizen | <ul> <li>Shipper's Passport copy</li> <li>Shipper's Georgian ID copy (if Georgian citizen)</li> <li>General Packing list (which is prepared during Packing by local agent)</li> <li>Detailed list (prepared by local agent)</li> <li>Proforma invoice (will be provided by local agent)</li> <li>Notarized Power of Attorney (text to be provided by local agent)</li> <li>If shipper is a foreign citizen, the local agent will need the shipper's GEO Tax Registration number which (s)he must obtain at Revenue Service in Tbilisi or other main city (Poti/Batumi/Kutaisi)</li> <li>Export Permission from the Ministry of Culture for cultural items such as painting, carpets, antique, musical instruments (must be collected by the owner at the ministry of Culture in Georgia).</li> <li>Cargo AWB/CMR/BL copy</li> </ul> | <ul> <li>Free from VAT /Tax &amp; Duties.</li> <li>When the shipper is a Russian citizen, he/she cannot ship any electronic items.</li> </ul> | <ul> <li>Once all docs passed to GEO customs, cargo will enter the line: there is a system at customs which applies only non-diplomatic cargos, during export Customs clearance: once all docs are submitted to Customs, system shows light: either Yellow or Red:         <ul> <li>Yellow means everything is in order and clearance will be completed shortly;</li> <li>Red means Customs officer will check all docs properly again, open some boxes &amp; expertise the contents according to provided docs and in case of any discrepancy shipper will be charged with Penalty – but this rarely applies for export cases.</li> </ul> </li> <li>Prohibited items for exportation:         <ul> <li>Any musical instruments including Guitar, Grand or upright Pianos with elephant's lvory keyboards manufactured since 1974,</li> <li>if after expertise its determined that manufacture is since 1974 CITEs certificate will be required &amp; customs have right to confiscate the item even if certificate will be obtained &amp; presented!</li> <li>Weapons of all kinds</li> <li>Pornography</li> </ul> </li></ul> |


