Removal Goods – HHG/PE	<ul style="list-style-type: none"><li>▪ Copy of passport.</li><li>▪ Copy of SA ID where available.</li><li>▪ Shipments to the USA / Canada: the local agent must receive a full address, contact telephone number and email address of assignee prior to booking of the container.</li></ul>		
Prohibited items		<ul style="list-style-type: none"><li>▪ Animal skins as well as trophies and other animal products.</li></ul>	<ul style="list-style-type: none"><li>▪ If listed on the endangered species, then it is totally prohibited.</li><li>▪ Shipping lines have placed a total ban on all Animal Skins and Trophies.</li></ul>
