Household goods	<ul style="list-style-type: none"><li>For Spanish citizens and foreign citizens:<ul style="list-style-type: none"><li>Passport copy</li><li>DNI or NIE copy</li><li>Valued inventory list in Spanish, valued and signed by the customer</li><li>Set of forms duly signed</li></ul></li></ul>		<ul style="list-style-type: none"><li>NIE number is obtained when applying for a work/residence permit. NIE number must be registered at AEAT database (Spanish treasure department).</li><li>The customs forms are provided by the local agent in Spain.</li><li>All documents must be available before packing.</li><li>As from 1 January 2024, a tax on plastic used is due. The applicable tax is due on non-recycled plastic contained in the taxed products.</li></ul>

Used motor vehicles and motorcycles	<ul style="list-style-type: none"><li>For Spanish citizens and foreign citizens:<ul style="list-style-type: none"><li>Photocopy of passport</li><li>DNI or NIE copy</li><li>De-registration copy ("Baja de Tráfico")</li><li>Car/motorcycle's purchase invoice duly signed</li><li>Set of forms</li><li>Vehicle registration ("Permiso de Circulación")</li><li>Technical datasheet ("Ficha Técnica")</li></ul></li></ul>		<ul style="list-style-type: none"><li>For new vehicles the invoice has to be issued with the foreign address of the customer and without VAT</li><li>De-registration is issued by Spanish traffic department.</li><li>For diplomatic vehicles will be necessary the embassy letter and the approval of the de-registration.</li><li>The customs forms are provided by the local agent in Spain.</li><li>All documents must be available before the</li></ul>
