Household Goods/PE Returning Citizen	<ul> <li>Proof of residence in B&amp;H not older than 6 months (CIPS certificate)</li> <li>Certificate issued by the Bosnian embassy / consulate abroad whereby proving importer's previous and continuous stay out of B&amp;H in a duration of minimum 12 consecutive months or minimum 12 months within a time frame of 4 years</li> <li>Statement by the importer of the day of his arrival date from the origin country</li> <li>Statement that he has never benefited from this customs privilege as per article 176, Paragraph 4, Annex 3 of Customs Law of B&amp;H</li> <li>Statement wherein customer bonds to use the personal property in the very same purpose at his place of residence in B&amp;H</li> <li>Statement wherewith customer bonds to cover any customs taxes and or duties that may arise</li> <li>Inventory list</li> <li>On the special request of the customs official, proof that the personal property was in a beneficiary's possession in a period of minimum 6 months until the day of departure from the foreign country.</li> </ul>		Statements signed by the customer must be in Bosnian language.

Household Goods/PE Foreign citizens	<ul> <li>Dated and valued Inventory list</li> <li>Official document proving that customer's common residence was elsewhere than Bosnia &amp; Herzegovina for a period of minimum 12 months continuously</li> <li>Lease contract signed for a minimum period of 2 years, officially verified by Bosnian city hall authorities</li> <li>Residence permit issued by the Bosnian Security Ministry (Foreign Citizens Department)</li> <li>Statement that customer did not previously benefit from this privilege as per Article 176, Paragraph 4 and Annex 5 of Customs Law of B&amp;H</li> <li>Statement saying that the goods subject to importation are used, and have belonged to the importer within the period of 6 months prior to exportation</li> <li>Statement confirming that this secondary residence will not be rented to a third party</li> <li>Statement wherewith customer bonds to cover any customs taxes and or duties that may arise.</li> </ul>		Statements signed by the customer must be in Bosnian language.

	<ul> <li>Pro forma invoice</li> <li>Proof that the personal vehicle was in a beneficiary's name for the period of minimum 6 months.</li> <li>Diplomats</li> <li>Original car registration documents (vehicle should not be older than 7 years)</li> <li>Pro forma invoice</li> <li>Tax exemption certificate issued by the Bosnian Ministry of Foreign Affairs (client needs to be registered as a diplomat)</li> <li>Copy of passport.</li> <li>Foreign citizens (non-diplomatic status)</li> <li>Original car registration documents (vehicle should not be older than 7 years)</li> <li>Pro forma invoice</li> <li>Residence permit issued by the Bosnian Security Ministry (Foreign Citizens Department)</li> <li>Copy of passport</li> <li>Bank guarantee amounted to the customs taxes and Bosnian VAT duties as per pro forma invoice or customs officials' estimate.</li> </ul>		returning Angolan Diplomats, and Foreign Diplomats. Consignments including a car need an Import License regardless of their value.  All containers shipped with vehicles will be transferred to FAYOL terminal where they will be inspected.
