Household Goods (non-diplomatic shipments)	<ul style="list-style-type: none"> ▪ Original CE 101 in duplicate. ▪ Copies of passport including page with date of entry in Botswana. ▪ Detailed inventory for attestation and the declared value for customs. ▪ Long Term or Permanent Work and Residence permit or Exemption Certificate (for foreigners). ▪ Letter of appointment stating that duration of contract is greater than 2 years (for foreigners). ▪ Letter from employer at origin confirming description of appointment in country of origin, duration of appointment and that appointment is terminated + date of termination (for returning Botswana citizens). ▪ Letter of recall from Ministry of Foreign Affairs (returning Botswana officials from Botswana government representations). 	<ul style="list-style-type: none"> ▪ Duty Free entry in the following circumstances : <ul style="list-style-type: none"> ▪ Personal effects, household furniture including equipment necessary for the exercise of the calling, trade or profession of the person, other than Industrial, Commercial or Agricultural Plant excluding Motor vehicles. ▪ The Bona Fide property of a natural person and members of his family, imported for his own use on change of residence to Botswana for the purpose of taking up employment or for the permanent settlement. ▪ Such goods may not be sold or disposed of to other persons within two years from the date of Importation. ▪ A free entry is only permissible if done within 6 months of the date of issue of the work permit. Thereafter duties and taxes would apply. 	<ul style="list-style-type: none"> ▪ The following articles may be admitted free of duty/sales tax, but it is advisable not to include any in a shipment of personal effects as this would increase the likelihood of physical examination which could lead to delays and extra charges: <ul style="list-style-type: none"> ▪ Wines 2 litres free and pay tax for the rest ▪ Spirits and other alcoholic beverages 1 litre ▪ Cigarettes 200 ▪ Cigars 20 ▪ Cigarette or pipe tobacco 250 grammes ▪ Perfumes 50 ml ▪ Toilet water 250 ml ▪ Form CE 101 is subject to an application supported by the following : <ul style="list-style-type: none"> ▪ A list of effects showing approximate values. ▪ A residence permit and a letter of employment.

Motor Vehicles (non-diplomatic shipments)	<ul style="list-style-type: none"> ▪ Original customs form CE101 in duplicate. ▪ Registration papers from country of origin, with official translation into English if the original is in a language other than English. ▪ An evaluation of motorized vehicle from accredited dealer or equivalent ▪ Document showing that the vehicle has been in the owner's possession abroad for more than 365 days before the exportation of the vehicle from origin (original purchase invoice, insurance certificate etc.). ▪ Copies of passport including page with date of entry in Botswana. ▪ Long Term or Permanent Work and Residence permit or Exemption Certificate (for foreigners). ▪ Letter of appointment stating that duration of contract is greater than 2 years (for foreigners). ▪ Letter from employer at origin confirming description of appointment in country of origin, duration of appointment and that appointment is terminated + date of termination (for returning Botswana citizens). ▪ Letter of recall from Ministry of Foreign Affairs (returning Botswana officials from Botswana government representations). 	<ul style="list-style-type: none"> ▪ A free entry is only permissible if done within 6 months of the date of issue of the work permit. Prohibited Goods		<ul style="list-style-type: none"> The importation and exportation of the following goods in Botswana is completely prohibited : <ul style="list-style-type: none"> Narcotic, habit-forming drugs and related substances in any form. Military firearms, ammunition and explosives. Indecent and obscene material such as pornographic books, magazines, films, videos, DVDs and software. Semi-precious stones such as agate, amethyst, Botswana pink, jade, rose quartz, carnelian, chalcedony, crystal quartz, tourmaline, jasper, tanzanite, garnet, moss agate, tiger's eye, sodalite, aquamarine, azurite and malachite. 	<ul style="list-style-type: none"> It is important to note that possession of prohibited goods is illegal and may result in seizure of such goods and prosecution of the person importing or exporting such goods.
<ul style="list-style-type: none"> Duty free allowances 		<ul style="list-style-type: none"> Personal effects, sporting and recreational effects, new or used : <ul style="list-style-type: none"> imported by non-residents of Botswana for their own use; imported by persons making a bona-fide change of residence to Botswana. exported by residents of Botswana for their own use whilst abroad and subsequently re-imported by such residents. The goods must be identifiable as those exported from Botswana. The following articles and consumables 	<ul style="list-style-type: none"> Duty will be payable at the applicable rates where travellers import goods exceeding the above allowances. Travellers importing goods for business or commercial purpose will not qualify for the above allowances. The concession for new and used goods do not apply to such goods imported by residents of Botswana returning after an absence of less than 48 hours. With the exception of those relating to tobacco and alcoholic products, the
