<p><b>Removal Goods for foreign citizens coming permanently to Estonia</b></p>	<ul style="list-style-type: none"> <li>▪ Full valued inventory list in English.</li> <li>▪ Photocopy of passport.</li> <li>▪ A document proving the residence in a third country for the past 12 months.</li> <li>▪ A letter providing that the shipper/importer is employed in Estonia.</li> <li>▪ Residence/work permit issued by Estonia Authorities.</li> <li>▪ A letter entitling the removal agent to represent the importer with the Customs Authorities.</li> </ul>	<ul style="list-style-type: none"> <li>▪ Duty free.</li> </ul>	<ul style="list-style-type: none"> <li>▪ The duty free exemption is only applied to persons whose permanent residence has continuously been outside the EU for at least 12 months.</li> <li>▪ The resettler can import personal belongings with tax exemption for 12 months from the date he/she took residence in the EU.</li> <li>▪ Personal belongings, to which the exemption is applied to, have to generally have been in the resettlers use in his/her former permanent residence at least for 6 months before the date his/her permanent residence is no longer in the third country.</li> </ul>
<p><b>Removal goods for Estonian citizens returning to Estonia</b></p>	<ul style="list-style-type: none"> <li>▪ Full valued inventory list in English.</li> <li>▪ A letter entitling the removal agent to represent the importer with the Customs Authorities.</li> <li>▪ A letter providing that the importer has been employed abroad more than 1 year.</li> <li>▪ Photocopy of passport.</li> <li>▪ Evidence documents for living in a third country (for example living permit, work permit, a lease, non-EU country's registration card, application for a passport,</li> </ul>	<ul style="list-style-type: none"> <li>▪ Duty free if the importer has been abroad more than 1 year.</li> </ul>

	<p>receipt of payment of rent, address registration, travel tickets, employer's certificate). Customs has the right to ask explanations for the documents presented.</p>		
<b>Diplomats' removals</b>	<ul style="list-style-type: none"> <li>▪ Photocopy of passport.</li> <li>▪ A letter entitling the removal agent to represent the importer with the Customs Authorities, must be completed by the Embassy.</li> <li>▪ Customs declaration of diplomatic merchandise.</li> <li>▪ Inventory list in English.</li> </ul>	<ul style="list-style-type: none"> <li>▪ Duty free.</li> <li>▪ Import of alcohol is allowed for diplomats. It has to be justified and has to remain reasonable. Please contact your local Embassy to check the allowed quantities before shipping.</li> </ul>	
<b>Automobiles and motorbikes</b>	<ul style="list-style-type: none"> <li>▪ Purchase docs.</li> <li>▪ A letter entitling the removal agent to represent the importer with the Customs Authorities.</li> <li>▪ Photocopy of passport.</li> <li>▪ A letter providing that the importer is employed in Estonia</li> <li>▪ Residence/work permit issued by Estonian Authorities.</li> <li>▪ Original technical passport of the vehicle.</li> </ul>	<ul style="list-style-type: none"> <li>▪ Duty free if the importer has been abroad more than 1 year.</li> </ul>	
<b>Alcohol</b>	<ul style="list-style-type: none"> <li>▪ Same as for Removal goods.</li> </ul>	<ul style="list-style-type: none"> <li>▪ Forbidden inside the HHG.</li> <li>▪ Import of alcohol is allowed for diplomats. It has to be justified and has to remain reasonable. Please contact your local Embassy to check the allowed quantities before shipping.</li> </ul>	<ul style="list-style-type: none"> <li>▪ The importation duty-free limit is (for passengers), inside the luggage: <ul style="list-style-type: none"> <li>▪ Max 1 litre strong alcohol (above 22 %);</li> <li>or</li> <li>▪ Max 2 litres light alcohol (below 22 %).</li> <li>▪ 4 litres wines.</li> <li>▪ 16 litres beer.</li> </ul> </li> </ul>
<b>Dogs, cats, birds</b>	<ul style="list-style-type: none"> <li>▪ Same as for removal goods plus:</li> <li>▪ Veterinary certificate of origin country which proves the animal is vaccinated and healthy.</li> </ul>	<ul style="list-style-type: none"> <li>▪ Duty free.</li> </ul>

<b>Plants and vegetable products</b>	<ul style="list-style-type: none"> <li>▪ Same as for removal goods plus:</li> <li>▪ Phytosanitary certificate from the National Plant Protection Service of the country of origin.</li> </ul>	<ul style="list-style-type: none"> <li>▪ Duty free.</li> </ul>	
<b>Other goods</b>			<ul style="list-style-type: none"> <li>▪ For specific customs regulations it is recommended to contact your local agent prior to shipment.</li> </ul>
