<b>Personal effects</b>	<ul style="list-style-type: none"><li>▪ Detailed, dated and signed inventory in Portuguese valued in euros or CFA franc, on which a contact address at destination must appear.</li><li>▪ New effects:<ul style="list-style-type: none"><li>▪ Detailed inventory showing exact invoice amounts of new effects on which a contact address at destination must appear</li><li>▪ Original invoice not older than 6 months with address at destination (not handwritten)</li><li>▪ Residence certificate or work permit from employer explaining that the employee obtained a new contract</li><li>▪ Transfer letter</li><li>▪ Copy of valid passport.</li><li>▪ For private clients only: taxpayer number (of the private institution or individual)</li></ul></li></ul>		<ul style="list-style-type: none"><li>▪ For new effects, a tax of 35%-55% of the CIF value will be charged (for civilians and military clients).</li><li>▪ For new effects not older than 6 months:<ul style="list-style-type: none"><li>▪ Name and address at destination</li><li>▪ Total invoice excluding VAT</li><li>▪ SIRET or SIREN numbers of supplier</li></ul></li><li>▪ The supplier must state the exact origin of the goods on the invoice, showing whether the goods are from within or outside the EU.</li><li>▪ Not accepted by customs:<ul style="list-style-type: none"><li>▪ Till slips</li><li>▪ Delivery notes</li><li>▪ Order forms</li><li>▪ Sales slips for export, intended for airport customs and not marine customs</li></ul></li></ul>
<b>Vehicles</b>	<ul style="list-style-type: none"><li>▪ Valued, dated and signed inventory</li><li>▪ Original vehicle documents</li><li>▪ ID or passport copy of vehicle owner</li><li>▪ New vehicle: same as above</li></ul>		<ul style="list-style-type: none"><li>▪ All vehicles are subject to Customs duties if shipment not diplomatic.</li><li>▪ All vehicles not older than 10 years can be imported but a tax of 58% of the CIF value will apply. The importation will be subject to the agreement of local agent.</li><li>▪ Contact your local agent for further information on importing vehicles older than 10 years.</li></ul>
