Prohibited items		<ul> <li>Weapons of all kinds</li> <li>Animal products</li> <li>Drugs</li> <li>Alcohols and spirits of more than 75% content</li> <li>Pornography</li> <li>Medicines</li> <li>Food</li> <li>Plants</li> <li>Collectible coins and stamps</li> <li>Credit cards, money</li> <li>Precious metal</li> <li>Religious items</li> <li>Toxic and radioactive material</li> </ul>

Motor vehicles	<ul><li>Waybill</li><li>Owner's passport copy</li><li>Certificate of title</li><li>Origin purchase invoice</li><li>Power of attorney</li></ul>		<ul> <li>Duties and taxes on the imported vehicle are to be paid (amount of duties depends on the car's year of manufacture, make, model, volumetric capacity of engine, etc.)</li> </ul>
Pets:	<ul> <li>Owner's passport copy</li> <li>Stamped health certificate issued by a government veterinarian of origin country, showing the name, sex, breed of the pet, as well as all vaccination records</li> </ul>		<ul> <li>Quarantine may be required depending on the type of pet and the country of origin.</li> </ul>
