<b>USED HOUSEHOLD GOODS/PERSONAL EFFECTS (Foreign nationals, non-diplomatic)</b>	<ul style="list-style-type: none"><li>▪ AWB/CMR/SMGS</li><li>▪ Shipping invoice</li><li>▪ Packing list</li><li>▪ Copy of passport</li><li>▪ Copy of diplomatic cards or ID/confirmation of employment</li><li>▪ POA (sample provided by destination agent in Tajikistan).</li><li>▪ Export Customs declaration</li></ul>	<ul style="list-style-type: none"><li>▪ Foreign nationals coming to Tajikistan for executing projects/contracts in Tajikistan will have to come only on employment visas.</li><li>▪ Preferential procedure for the movement of goods imported into the customs territory of the Republic of Tajikistan by individuals with complete exemption from payment of customs duties, taxes without application of prohibitions and restrictions established by regulatory legal acts of the Republic of Tajikistan (except for goods prohibited or restricted to export from the Republic of Tajikistan or import into the Republic of Tajikistan), is made in the following cases:<ul style="list-style-type: none"><li>▪ For the importation of goods (except vehicles), not intended for production or other business activities, whose total value in equivalent terms does not exceed US\$ 1,000 and their total weight does not exceed 50 kilograms per person;</li><li>▪ Simplified customs clearance procedure with uniform rates of customs duties, taxes are not applied if the customs value of goods imported by a natural person exceeds \$1,000 and 50 kilograms. <b>Prohibited Items</b>		<ul style="list-style-type: none"> <li>▪ Firearms, Weapons, ammunition of any type</li> <li>▪ Narcotics</li> <li>▪ Obscene Literature, Pornographic Material</li> <li>▪ Wildlife items like ivory, horns etc.</li> <li>▪ Drones</li> <li>▪ Toxic material</li> <li>▪ Radioactive material</li> </ul>	<ul style="list-style-type: none"> <li>▪ These items are strictly prohibited into Tajikistan.</li> <li>▪ Do not pack these items under any circumstances.
